Main conclusions

- Most significant problem: theft or misappropriation of archival material
- Hidden problem
- Insufficient cooperation
- It is important to take preventive measures: registration, safety and security measures, code of ethics (integrity), procedures, check provenance
- Awareness



Recommendations

- Development of a uniform and coordinated approach (legislation, registration) by institutions involved (archives, police, Inspectorate)
- Development of a uniform method regarding safety and security measures (Cultural Heritage Agency, Inspectorate, Royal Library, National Archives, archival sector)
- Development of a joint vision regarding supervision and quality inspection (state, municipal and provincial archival inspectors)




Cultural Heritage Inspectorate

- Assistance with export permits
- Inspection of collections and objects of national importance
- Cooperation with Customs and police
- Cooperation with international organizations


Research: dilemma: stolen objects or missing administratively




Research: preventive measures
